Introduction

ASPIRE2025 is a partnership between major New Zealand research groups carrying out research to help achieve the Government's goal of a tobacco-free Aotearoa by 2025. ASPIRE2025 brings together leading tobacco-free researchers and health service groups in New Zealand and strengthens existing collaborations. We have developed and strengthened our sector partnerships and are grateful to the Health Promotion Agency, whose staff have provided administrative support for our seminar series.

This report briefly outlines details of ASPIRE2025's activities and achievements since its launch in July 2011 and sets out the group's plans for 2013.

Research Activity

Projects and papers

The ASPIRE2025 team had an extremely busy year conducting and disseminating research, developing ideas, and applying for further research funding. During the year we published or had accepted 28 journal articles. A list of publications is provided at the end of this report. Team members presented more than 40 papers or posters at major international conferences and ASPIRE2025 featured prominently at the Tobacco-Free Aotearoa Conference in Wellington in November 2012 (see Appendix 1).

The ASPIRE2025 network has identified seven primary tobacco control research themes:

- Smokefree communications, led by Janet Hoek
- Smoking cessation systems, led by Julian Crane
- Policy and regulatory research, led by George Thomson
- Research on smoking among young people, led by Rob McGee
- Māori public health and tobacco misuse, led by Heather Gifford
- Smokefree Pasifika, led by Stephanie Erick
- Research capacity development, led by Chris Cunningham

The following review outlines work completed in these areas.

Smokefree communications

We continued work on an HRC-funded project examining plain packaging, and completed this contract in 2012. Led by Janet Hoek, the project also involved Phil Gendall, Richard Edwards, George Thomson and Heather Gifford. Four papers from this study have been published and another is currently under review. This final paper, reporting on a study led by Phil Gendall, addressed a crucial gap in existing knowledge and makes an important contribution to pending international litigation.

We also completed a major piece of work funded by the Ministry of Health that examined new smokefree messages. Janet Hoek led this project, which comprised three phases. Team members included Ninya Maubach, Stephanie Erick, Dan Tautolo, Heather Gifford, Richard Edwards and Rhiannon Newcombe (Health Promotion Agency). As well as the large report delivered to the Ministry, we have also produced one journal article, and several conference papers. Ninya Maubach is writing a further paper and she and Janet Hoek will complete two further academic outputs once additional interviews with women who are pregnant and smoking are concluded.

Ben Healey began a short-term contract with ASPIRE2025 and has prepared an analysis of smokefree 2025 discourse by politicians. He has also examined patterns of interaction among Quitline quit blog users. Ben gave two presentations outlining preliminary findings at the ASPIRE2025 gateway session, held prior to the Tobacco-free Aotearoa Conference in 2012.

In late 2012, Anaru Waa obtained an out-of-season University of Otago Reseach Grant (with Janet Hoek and Richard Edwards) to examine the advertising campaign undertaken by British American Tobacco to oppose plain packaging. Work on this project has commenced and will conclude in mid-2013.

Smoking cessation systems

Julian Crane and Brent Caldwell completed a large HRC funded Randomised Controlled Trial (RCT) of a combined nicotine mouth-spray and patch versus a placebo mouth-spray plus patch; findings will be submitted for publication shortly. In February 2013, Julian and Brent will commence a second RCT of

nicotine metered dose inhalers. They have established a working group of CCDHB and Hutt Valley cessation staff and researchers to help improve cessation services.

Julian and Brent have also completed a pilot study of snus acceptability amongst hospitalised smokers at CCDHB. This work was presented at the 2012 European Respiratory Society annual meeting in Vienna.

Policy and regulatory research

George Thomson led several studies into smokefree places. Together with Vimal Patel and Nick Wilson, he further developed observation methods to determine the prevalence of smoking in outdoor places and cars, and butt littering. In collaboration with the Department of Information Science, the group developed a smartphone app to help record the extent of smoking in cars worldwide.

Phil Gendall led an online survey testing arguments advanced by tobacco companies in relation to plain packaging and other tobacco control measures. Results relating to plain packaging were recently published and attracted considerable media interest; a further paper outlining responses to other potential measures is currently under review. We propose repeating this survey to monitor changes in public opinion over time.

Louise Marsh led research examining the implementation of smokefree policies at tertiary institutions and assessing the extent to which staff and students at the University of Otago supported a completely smokefree campus. Two papers from this research will be submitted in early 2013.

Richard Jaine led a project examining retailers' views on the legislation removing point of sale displays of tobacco products, before this was implemented. This was funded by Regional Public Health. Louise Marsh and Lindsay Robertson also undertook retail research and examined the spatial characteristics of tobacco retailers in New Zealand.

Research on smoking among young people

Janet Hoek and Richard Edwards secured a Marsden grant to explore the degree to which young adults starting smoking are exercising true 'informed choice'; George Thomson, Heather Gifford and Stephanie Erick are also involved in this work. We recruited Rebecca Gray as the PhD student to work on the study; she began her PhD in March this year and interviews are underway as part of the first phase of this project.

Rob McGee and Louise Marsh undertook three studies examining trends in smoking among young people and resulted in two publications and one conference presentation. Qualitative research with young people explored social supply and smoking cessation and resulted in one submitted paper with a further paper to be submitted early 2013.

Ben Healey has analysed ASH Year10 data (a set of cross-sectional surveys) to estimate exposure to second hand smoke in cars. A brief report outlining the findings, which reveal high levels of exposure, has just been submitted, and these results will be written up for publication in 2013.

Māori public health and tobacco misuse

Heather Gifford, Research Director of Whakauae Research, our Māori partner, has been actively involved in several programmes, particularly the plain packaging, smokefree messages, smokefree spaces and informed choice projects. In addition, Heather and her team secured an HRC grant to examine kaupapa Māori methods of promoting smokefree behaviour among Māori nurses, many of whom administer cessation support and advice. This work commenced in 2012 and will conclude in 2014.

Smokefree Pasifika


ASPIRE2025 frequently drew on our Pacific partners' expertise including Stephanie Erick (Director of Tala Pasifika) and El-Shadan Tautolo (AUT), who were involved in the smokefree messages study and are working on the informed choice project. In addition, El-Shadan Tautolo obtained funding for the Pacific Duty Free Project, which commenced in early 2013. This project also involves Heather Gifford and Richard Edwards and will assess the behaviour of Pacific smokers and non-smokers with regard to duty free cigarettes. More specifically, it examines the extent to which Pacific smokers and non-smokers are buying and smoking/distributing duty free tobacco, explores patterns of behaviour around purchasing duty free tobacco and whether it is being used as a strategy to circumvent tax increases and examines how this behaviour is viewed within the Pacific community.

Conference Attendance and Presentations

ASPIRE2025 members presented papers and posters at numerous international and local conferences in 2012. They received awards for research excellence and invitations to present their research findings to several key audiences.

15th World Conference on Tobacco or Health 2012

Several ASPIRE2025 members attended the 2012 World Conference on Tobacco or Health, held in Singapore in late March; we presented a total of eight posters, gave two invited oral presentations, and participated in a hemi-plenary session on tobacco endgames.



The poster "Which smokers support a tobacco endgame and increased regulation of the tobacco industry?" was judged one of six best posters at the conference.

Tobacco-Free Aotearoa Conference 2012



ASPIRE2025 team members presented 18 papers (out of a total programme of around 60 papers). ASPIRE2025 research was further showcased at a gateway session preceding the Smokefree 2025 conference.

Marketing and Policy conferences

We have also been well represented at leading marketing conferences. Phil Gendall, Ninya Maubach and Janet Hoek attended the Australian and New Zealand Marketing Academy Conference (ANZMAC) in Perth in late 2011 and received the "best in track" award for a paper on social smoking. This has since been published in *Tobacco Control* and was selected by the BMJ as a study they publicised to the media. Ninya Maubach and Phil Gendall attended the 2012 ANZMAC conference in Adelaide, and presented on smoker stigmatisation, cessation messages targeted to pregnant women, and public attitudes to plain packaging. Janet Hoek attended the 2012 Marketing and Public Policy Conference in Atlanta and presented three papers on ASPIRE's tobacco control work. She also gave a seminar on endgames to the Centre for Tobacco Control Research and Evaluation (University of California, San Francisco). Phil Gendall and Janet Hoek attended the 2012 International Social Marketing Conference in Brisbane and presented four papers on ASPIRE2025 tobacco control work.

Invited Presentations

Richard Edwards gave an invited hemi-plenary presentation on 'Developments with endgames in New Zealand' at the 15th World Conference on Tobacco or Health, Singapore. He gave an invited presentation on access to tobacco at the 'Smoking and health', progress, lessons and priorities for a smokefree UK event at the Royal College of Physicians in London. Richard also discussed evidence for 'upstream' policies to achieve the 2025 goal at the 20th Cochrane Colloquium, in Auckland and also gave invited presentations on the 2025 goal at a range of meetings across New Zealand including the Australian and New Zealand Society of Respiratory Science Annual Scientific Meeting, and New Zealand Lung Cancer Conference.

Research Funding

In late 2011, ASPIRE2025 achieved recognition as a University of Otago research theme. Research themes reflect pre-eminent areas of research activity that the University recognizes and supports.

During 2012 we carried out research funded by HRC, the Marsden Fund, and The Ministry of Health, amongst others. We have current applications under review with the HRC (two project proposals) and with a range of other funders. Projects funded during 2012 included:

- Tobacco retailers' attitudes and knowledge of the Smokefree Environments Amendment Act 2011 and other tobacco control measures, PI Richard Jaine, Regional Public Health
- Evaluation of BAT plain packaging campaign, PIs Anaru Waa, Richard Edwards and Janet Hoek, University of Otago Research Grant
- Evaluation of tobacco tax increases, co-investigators, PI Sally Caswell [SHORE], Ministry of Health
- Estimation of the effect of dissuasive tobacco sticks, PIs Janet Hoek and Phil Gendall, Heart Foundation
- Smokefree New Zealand Universities, PI Louise Marsh, Department of Preventive and Social Medicine PBRF Fund

Sector, community and public engagement

ASPIRE2025 Seminars

Organising seminars to engage with the public health practice and policy community is a major focus for ASPIRE2025. During 2012 we organised and participated in a range of key seminars; we are grateful to the Health Promotion Agency for the administrative support its staff have provided.

Smokefree Outdoor Spaces

George Thomson organised the first 2012 ASPIRE seminar as part of the Department of Public Health's Summer School programme, held in February 2012. He outlined findings from the theme he leads examining smokefree outdoor spaces and more than 30 people attended his research day. Full resource details available here:

Tobacco Industry Targeting of Low Income Women

The second seminar took place in April when Janet Hoek hosted Associate Professor Stacey Anderson, from the Centre for Tobacco Control Research and Evaluation (University of California, San Francisco). Stacey presented a public seminar exploring how the tobacco industry marketed its products to low income women (a demographic where smoking prevalence is disproportionately high in New Zealand). More than 50 people attended this seminar, which was held in Wellington. Stacey also presented seminars on allegedly reduced harm products to receptive audiences in both Dunedin (more than 30 attended) and Wellington. Endgame Strategies

In May, we aligned with ASH (NZ) and the Smokefree Nurses Organisation and hosted Professor Ruth Malone, current editor of *Tobacco Control* (the leading journal in this field). George Thomson represented ASPIRE2025 at an Auckland presentation; Richard Edwards spoke in Wellington, and Janet Hoek represented ASPIRE2025 in Christchurch. While she was in Wellington, Professor Malone also attended a workshop with ASPIRE2025 members and we had a valuable session examining endgame approaches and social movements.

Māori and Pacific Tobacco Control

Our Māori and Pacific partners (Whakauae Research and Tala Pasifika) organised a gateway event immediately prior to the Public Health Association conference. The gateway was fully subscribed, with approximately 60 attendees from around NZ. Among other work, they presented findings from the Ministry of Health contract examining smokefree messages and priority audiences. MP Hone Harawira presented an address at the gateway session.

Plain Packaging

A little later in September, Janet Hoek hosted Professor Melanie Wakefield, who was the keynote speaker at a full-day seminar on plain packaging, held in Wellington. Nearly 60 people attended this day, despite the fact it fell very soon after the PHA conference (unavoidable, due to other commitments Professor Wakefield had in NZ). This seminar provided an opportunity to showcase research findings from our HRC funded project into plain packaging and four presenters outlined details of five studies:

Seminars planned for 2013

In 2013, Associate Professor Tim Dewhirst and Dr Wonkyong (Beth) Lee will present a summer school day-long seminar on tobacco control and social marketing. Tim will also present a separate seminar on using culture-jamming to create a social movement, and Beth will give a talk on rationalisation and regret among smokers.

Professor Stanton Glantz, Director of the Centre for Tobacco Control Research and Evaluation (University of California, San Francisco), will visit New Zealand in April 2013, and Professor Hoek is currently arranging details of the seminars he will present while here, in Auckland, Wellington and Dunedin.

Details of at least two other seminars will be announced in the next few months.

The ASPIRE2025 website (<u>www.aspire2025.org.nz</u>) has been further developed and updated, and it is now a major publicity and dissemination medium for the group. The website often attracts over 1,000 page views per month.

Media Activities

We have had very strong media interest in our research findings. Most of our published papers have been accompanied by press releases, resulting in a high level of media coverage and we are frequently asked to provide comment on policy developments.

We have also engaged pro-actively in public debates, notably through contributions in national newspapers including op-ed pieces on plain packaging in the *Dominion Post*, on Smokefree Outdoor areas in the *Otago Daily Times*, and on the expansion of production at the Petone cigarette factory in the *Hutt News* (plus a letter in the *Dominion Post*).

Policy Submissions

We have made several policy submissions, including a detailed submission on excise tax to the Finance and Expenditure Select Committee (led by George Thomson and Richard Edwards) and on plain packaging to the Ministry of Health (led by Phil Gendall and Janet Hoek). George Thomson, Heather Gifford, Richard Edwards and Janet Hoek met with Minister Turia earlier in the year to discuss tobacco control policy.

Other contributions to the tobacco control sector

ASPIRE2025 members lead or participate in a range of tobacco control groups and organisations across the health and NGO sectors. For example, we are invited members of New Zealand Smokefree Working Group and ASPIRE2025 members sit on other influential committees including the National Lung Cancer Working Group, and the Cancer Society of New Zealand Health Promotion Committee. Janet Hoek is a member of the Australian Government's Expert Advisory Group on plain packaging. We meet regularly with the tobacco control team at the Ministry of Health. Janet Hoek and Richard Edwards chair the University of Otago Smokefree Campus working group. Richard Edwards, Anaru Waa and Rob McGee are members of the Research Coordinating Group of the NZ Youth and Tobacco Monitor Survey. Our research partners are also actively involved in sector contributions. For example, Tala Pasifika are represented on the National Smokefree Working Group; as a Smokefree Coalition Board member, a member of the Oceania Conference Programme Committee, and on the Ministry of Health, ABC Steering Group. Heather Gifford is a board member of Te Reo Marama. ASPIRE2025 members have contributed to the development of the Hawkes Bay 2025 Smokefree strategy and dissemination through providing expert advice and giving invited presentations.

Post-Graduate and Summer Students

Recruiting and supervising research students is another important facet of ASPIRE2025. We view this as an important contribution to achieving the 2025 smokefree goal by building capacity for tobacco control research in New Zealand.

Our current PhD students are:
